The mental health clinician is responsible for providing diagnostic assessments, therapy, counseling, and support services for adults experiencing mental health issues, communication challenges, or family conflict. This role is within the Reviving Roots membership community, Sanctuary. Sanctuary members pay a monthly fee which covers one therapy session (individual or group) per month.

- A therapist who will work as a part of an integrative wellness team. As part of this team, providers consult with one another to support the overall health of Sanctuary members.
- Black-identifying therapists with knowledge of and training toward liberatory healing practices are strongly encouraged to apply.
